Reopening Tiers SB County Moves To Orange Tier

Santa Barbara County has met the criteria to move into the Orange Tier of reopening as of April 21, 2021.

Santa Barbara County Health Department has given the OK to loosen restrictions. If we keep moving in the right direction, we will soon be moving into lower tiers and we will let everyone know when we can fully reopened.

At this time, the VDM pool is now able to open to two families at the same time. A maximum if 10 swimmers may use the pool simultaneously. Social distancing is still required on the pool deck and while in the pool area. You may also bring your own chairs to sit on during your time at the pool.

Bird's Nests Report Right Away

Migrating birds are here again and they are looking for places to nest. Nests usually may not be removed between February 15th and September 1st if they are completed and/or active. If you have questions about a nest and whether it can be removed, you should call the office to discuss. There is a large fine if nests are removed improperly and we would prefer to be contacted. Hosing nests down is not OK and is not going to resolve the situation. Migratory birds usually return to the same nesting location each year and we would have to deter the birds in these unwanted locations in a safe an effective manner.

Swallows generally work together as a team to build nests as quickly as possible and can build nest rapidly. If you see birds building nests in unwanted locations, please contact the office right away and we may be able to help.

Carport Cleaning Responsibility of All Residents

Each resident is required to keep their carport clean and free of debris/oil stains. Please sweep carports regularly and throw away debris in garbage bins. Do not sweep debris into the alley or a neighbor's carport. For oil leaks you may use a drip pan only, no carpet or carboard is permitted. You can remove oil stains by sprinkling kitty litter on the stains, grinding in with a shoe and sweeping up the kitty litter.

Staff may charge your unit for drip pans or oil stain clean up if this is not done on a regular basis. Take pride in your community and do your part to keep VDM looking beautiful. Your help is appreciated.
