Christmas Tree Pick Up Recycling of Trees

We will be picking up trees and utilizing them for our landscaping material needs.

For your convenience our Villa Del Mar staff will pick up your tree on one day only. January 5th between 8-9 am

Place your tree where you would normally place your bins on Wednesday January 5th. It is that simple and convenient.



Please make sure that you have removed all ornaments from your tree. Make sure to remove your tree stands and skirts. Trees must also be free of all tensile as to avoid damaging cutting equipment. Trees will not be picked up if they still have any of these items on them. Flock trees will be accepted this year.

Unit Improvements Unit Work Requires Approval

Please remember when making home improvements most changes require prior Board approval. Also alterations which effect exterior esthetics, such as windows and front & screen doors, satellite dishes and water softeners have set specifications they must meet

before they can be approved. Homeowner requests are reviewed and may need to be submitted to the Board for final approval.

You may make requests on the VDM website under Resident Resources tab at:

<u>www.villadelmarhoa.com</u> or by email or mail. All requests should include the following information:

- Unit number, homeowner name and contact information.
- Identify the change to be made and their location at your unit address.
- Attach brochures, pictures (if available) or drawings of proposed product plans.
- List installing contractor, their contact information and contractor's license number.

On certain items the office can give you permission to move forward with your project, however in some instances further information and approvals may be required. Make sure that the person or company doing the work has up-to-date insurance and is bonded. You can look up contractor's licenses to make sure they are current by going to: https://www.cslb.ca.gov/

EJ Harrison Food Waste New Law No Changes at this Time

EJ Harrison recently sent out notices regarding the new food waste law and changes to trash pick-up. Although they are working on a food waste system, there is no solution at this time. We are asked to dispose of food waste in trash cans as you have been previously doing. There is no easy solution to the collection of food waste in our community and we will be notified

if this changes. EJ Harrison is working with third party contractors to find ways to implement the new laws and we will let you know of any future impacts.

Gas Shut-Off Valves No Gas-What Should You Do

In light of our risk of earthquakes in

Southern California, we installed emergency gas shut off valves a few years ago.
Sometimes those valves can also be tripped by construction work or landscaping

activities. If your gas is off you should try calling the office first. We will send a crew member by to check on the earthquake emergency shut off valve. If it is after hours you may reach out to our emergency phone by calling (805) 220-0173.

The emergency shut off valves will also shut off in the case of an earthquake 5.4 magnitude or greater. This was done to prevent fire breakouts. In a major

earthquake, fires cause the most amount of property damage.

If you call the gas company they will charge a hefty service fee and this is a simple reset. Call the office at (805) 684-7430 for more

information.

Patio Drains, Gutters and Downspouts

Please Report Issues

Patio drains in every patio are for the purpose of preventing your unit from being flooded. Please make sure to locate them and keep patio drains clear of plants & roots, dirt, pots, debris and patio items. The Association is only responsible for the main drainpipe and not any connecting pipes. Most patio drains are located on each side of the cement entry from the gate about 18 inches to 24 inches from the cement walkway edge.

If you have a clogged or damaged gutter report to the office right away. Staff can't get on ladders when it is raining or windy. Your help is appreciated.

Street Sweeping Day: REMINDER: NO PARKING in the alleys and Driveways at VDM during this time. Street sweeping day is the 3rd Wednesday of every month. This month it is Wednesday, January 19, 2021.
